- Hanover Borough is undergoing a parking study with regards to a parking garage or repurposing of lots
- Main Street Hanover started an initiative to analyze and address homelessness and poverty
- Knorr-Bremse completed acquisition of Wabco. Ms. Trucksess will provide Ms. Kenetha Hansen a point
  of contact so that YCEA can conduct a business outreach visit
- Main Street Hanover hired a new employee Lauren Bupp, Event & Merchant Coordinator
