Hilton requires 2-3 weeks of staff training prior to opening. On November 14th interior staging will begin. Artwork installation has begun. The liquor license is in process and the JLHTP hospitality training program has been completed. There are three tenant spaces available. Michael mentioned that the hotel has assembled an outstanding executive team and are fully staffed and ready to start.

Chairman Kay stated that everything is coming together in the hotel. Also noted that we received a RACP grant for the Zion Church Property and will soon begin demo of the George Street Properties.
