#### **DEPOSITORY INSTITUTION RESOLUTION**

There were no additional nominations or comments. On a motion by Mr. Briddell, properly seconded by Ms. Dell a vote was conducted by roll call, the Board approved the resolution as presented.

# YCEA STAFF SUPPORT CONTRACT

A staff support contract was circulated prior to the meeting for the York County Economic Alliance to provide staffing for the York County Landbank Authority. The contract provided is the same as the 2022 staff support contract. There were no additional nominations or comments. On a motion by Chair Englerth, properly seconded by Mr. Staub, a vote was conducted by roll call, the Board approved the resolution as presented.

# **DISCUSSION ON INTEREST BEARING ACCOUNTS**

Ms. Nancy Barry shared that it is possible to have an interested bearing account for YCLBA, but accounts with authorities must be collateralized and the one that was researched with a high interest rate may not be. Adding an additional account may also make the transfer of funds more difficult.

Ms. Barry and her team are working with the auditors through the rest of the month, but welcome future discussions about interest bearing accounts.
