# PROJECT READINESS

#### **ENVIRONMENTAL RISK**

The Codorus Greenway partners have a demonstrated history of successful collaboration and implementation of significant infrastructure and community development initiatives. These effective working relationships, combined with the advanced progress made to date on the various components of the project, put the project partners in an ideal position and state of readiness to complete the proposed scope of work in a timely manner.

#### **REQUIRED APPROVALS**

**State and Local Approval:** Letters of support have been provided on the project website (www.codoruscreekpa.com) indicating state and local support for the overall grant application and respective local match contributions.

**NEPA:** It is anticipated that the project merits a Categorical Exclusion (CE), which will be completed alongside project design. *Thus, no delay associated with NEPA is expected.* 

**Right-of-Way** (ROW): No ROW is needed to accommodate the project.

**Permits**: The following required permits are anticipated:

#### **PROJECT SCHEDULE**

Upon receipt of the RAISE grant award notice, the project will be ready to begin design immediately, and construction is expected to start by Q1 2025. It is anticipated that construction for all project components will be complete by the end of 2027, well in advance of the both the obligation and the expenditure deadlines.



Utility Conflicts	Electric, water, and sewer utilities have been identified for appropriate relocation ar replacement, mostly located along the southern end of the project area (South Bend section).			
Stakeholder Coordination	Multiple planning efforts have occurred over the last five years for the Codorus Greenway. The project has support from the general public, downtown businesses, elected officials, and project partners. Any community impact issues that may arise in the future will be mitigated through clear and continuous communication.			
Federal Funding Process and Requirements	YCEA and its partners are familiar with the federal funding process and requirements including NEPA, certification, etc. YCEA and the City of York have regularly received and managed multi-million dollar grants from the U.S. Dept of Commerce's Economic Development Administration (EDA), and from the Community Development Block (CDBG) and other grant programs from the U.S Department of Housing and Urban Development (HUD). They have also managed smaller grants from USDOT and PennDOT. YCEA's grant management team has secured and managed over 18 grants worth more than \$100 million from Pennsylvania's Redevelopment Assistance Capital Program (RACP) and is also the main conduit for Small Business Administration (SBA) grants and loans into York County. YCEA has managed complex financing stacks for projects ranging from \$20-75 million and are experience in federal new market and historic tax credits that require significant due diligence and compliance. Their grant-management, accounting, and reporting experience will be great resources in managing a potential RAISE grant.			
Soil Contamination	A preliminary review of the right-of-way and adjacent properties has been completed as part of the master plan, to identify areas of concern, such as three specific sites where soil contamination is capped along the greenway. The project scope and budget includes tasks and funding for further environmental investigation, removal, and disposal. Soil testing will be completed to identify soil contamination, if any, within the greenway project boundaries, and tailor soil management practices to the actual site. If the soil contamination can not be mitigated through design, then it will be removed and appropriately disposed of off-site and replaced with clean fill and caps, as determined to be needed. During trail construction, site-specific soil management and health and safety plans will be prepared and an environmental monitor will be on-site whenever known contaminated soil is excavated.			
Schedule	The project schedule allows for flexibility that includes sufficient time to address potential issues, including for environmental coordination and utility relocation. The project is anticipated to be completed by the end of 2027, ahead of the federal deadline for expenditures.
